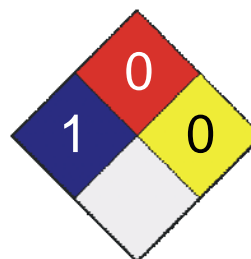

Emergency overview CAUTION

4. First Aid Measures

First aid procedures
